Dear Ms. Kravchenko,

Thank you very much for your letters drawing the EU's attention to the recent amendments in the legislation of Ukraine.

First of all, we would like to recall that the adoption of the environmental impact assessment (EIA) and strategic environmental assessment (SEA) legislation in Ukraine was strongly advocated by the EU several years ago. We have been also repeatedly stressing the need to ensure implementation and enforcement of this legislation in line with the provisions of the EU-Ukraine Association Agreement. The importance of the principle of environmental integration is also a cornerstone of the European Green Deal. In this context, we share your concerns that any derogation from the application of the EIA legislation shall be cautiously assessed and avoided. Commissioner Sinkevičius has already raised relevant concerns with the Minister of Environmental Protection and Natural Resources of Ukraine Ruslan Strilets. We will also follow up on this issue in our policy dialogue with the government of Ukraine.

We would also like to assure you that we will raise and follow-up with Ukrainian authorities on other issues raised in your second letter. At the same time, environmental dimension of the reforms in the area of agriculture and forestry has been always duly integrated in our policy dialogue with Ukrainian authorities and will continue to be so.
